

## LCA Meeting Notes for May 26, 2022

Mark prayed to begin the meeting.

Rhonda read the minutes of the last meeting. Approved as read.

Connie gave the treasurer's report. The current balance is \$64,781.52.

Barb discussed whether the group wanted to get an insurance rider for the Bang. For 1 million dollars, the premium cost is \$859. For ½ million dollars, the premium cost \$759. Jeff made a motion to get a 1 million dollars of coverage. Mark seconded. Motion passed.

News Force wants to cover the parade and wants a table and to have a prize box.

The wristband will allow for face painting on Saturday.

Share the Glow will do face painting as a fundraiser on Friday night.

There are some questions about who currently makes decisions about the modular. The village still owns the property and there is no village solicitor to draft a lease agreement. Council on Aging is asking for an update on the use of funds for the utilities for the modulars.

Marion Foundation is asking for an update regarding the use of their grant money. Barb will write a letter to Julie from the Foundation to give her an update. Connie has the impression that Dustin/Village would like to spend more money on the play structure itself. Barb had a rendering of a play structure. The play structure is \$34,000. Evelyn would like to spend the \$40,000 State money (attached to the 95 project) by August.

There was discussion about the play structures and what the group thought that the playground will look like. Barb will take the rendering done by Rob to council to ask them to approve the plan.

Jeff and Terri, Barb and Cheryl, Rhonda, Connie and maybe John Howard – will be on the subcommittee to meet after the Bang to make purchase/s for equipment.

Barb got a flier from Jim Anderson. Barb asked Bank to put it on the website.

Banner was ordered from the Bank. Vendors are bringing their own tents. Barb wants to set up the tents. Unknown where the tents can go.

Mark Cramer is coming. We need to know how big the train, how many cars there are to the train, and if he has insurance.

We can use council chambers for the silent auction. Barb has supervisors lined up. Auction is 7 pm on Saturday night. Mark to check on getting tables for the council chambers and for up-town.

Most all of Bang pre-sales are not on the website. Most sales are done in person. Cut-off date of on-line sales is June 7<sup>th</sup>. Barb and Mark to get together on the Wednesday before the Bang to sort ducks. To pull 200 ducks from the on-line sales to sell in person. Barb to pull the ducks.

Amy prepared the radio advertisement. She needs to get the website added to the spot; change the time of the parade; and add advertisement sponsored by Ohio Health.

The Marionairres are not coming to the Bang.

Terri needs the raffle basket for poker run by 10 am on Saturday morning.

Rhonda to develop rules for the pop a shot game.
